Recitals

There will be four recitals per year. They will be on October 28 and December 9, 2019 and February 10 and April 06, 2020. These will be on Monday at 5:00pm at Bethany Chapel.

Accompaniment sessions are booked directly with the accompanist. Students in this program will also have a bursary of 60 minutes to be scheduled privately with the Amici accompanist.

The students will have the opportunity to participate in the Calgary Performing Arts Festival (CPAF) as part of their Jr. Amici chamber group.
